

- KOPPER KITCHEN

The ordinance remained posted for more than five (5) consecutive days prior to the time for said public hearing on the 20th day of May, 1985.

ORDINANCE NO. 276

AN ORDINANCE RESTRICTING THE CONSUMPTION OF ALCOHOLIC BEVERAGES IN THE PARKS IN WILSONVILLE; AND AMENDING SECTION 3.020 OF THE WILSONVILLE CODE.

WHEREAS, the Parks Commission, at their regularly scheduled Park Commission meeting held February 13, 1985 at 6:00 o'clock p.m. Pacific Standard Time in the Council Chambers at 30000 SW Town Center Loop East, did review PC 84014 titled "Alcohol in City Parks - Revision Section 3 of the Code" with regard to the problems associated with consumption of alcoholic beverages in city parks in Wilsonville; and

WHEREAS, the Park Commission requested the Public Works Department Staff to review alcoholic consumption rules and regulations within city parks in other communities and provide this information at a subsequent Park Commission meeting; and

WHEREAS, the Public Works Department did review rules and regulations for alcoholic beverage consumption for city parks in six (6) other communities and presented said information to the Park Commission at their meeting held at 6:00 o'clock p.m. Pacific Standard Time on March 13, 1985 in the Wilsonville City Hall Council Chambers at 30000 SW Town Center Loop East; and

WHEREAS, the Park Commission recommended an ordinance be drafted and sent to the City Council amending Section 3.020 of the Wilsonville Code.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

3.020 USE AND CONSUMPTION OF ALCOHOLIC BEVERAGES

(1) Alcoholic Beverages may be consumed or used in Wilsonville city parks under the following conditions:

(a) Alcohol use or consumption shall refer to wines or beer only.

(b) In those areas where a reservation has been made and the applicant indicated on the application form that alcoholic beverages would be served. This does not in any way eliminate the reservation applicant from those rules and regulations administered under the Oregon Control Commission (OLCC).

(c) In other areas of the park, except for those designated in (2) below, alcohol as categorized in (a) above may be consumed if the container size is less than one (1) quart of beer or one (1) gallon of wine. For person(s) wishing to consume alcohol in containers larger than one quart of beer or one gallon of wine, a reservation permit is required. A reservation permit for consumption of alcoholic beverages in containers larger

than one quart of beer or one gallon of wine, can only be obtained if the applicant is twenty-one (21) years or older.

(2) Absolutley NO alcoholic beverages shall be allowed in the following areas:

(a) Swimming areas or boat dock.

(b) Restrooms

(c) Transporation of open containers from one area of the city park to another is prohibited. For reservation permit, alcoholic consumption is restricted to that area only.


(d) On soccer, baseball, softball, football, tennis fields or playing areas. Consumpition is restricted to the area outside the playing areas as defined by fences or as markings indicate.

(e) In, on, or within, touching distrance of a motor vehicle.


(3) A permit from the OLCC is required for the sale of alcoholic beverages.



IS ALCOHOL CONSUMPTION ALLOWED IN CITY PARKS

PORTLAND

1. Does not allow alcohol consumption in City parks in the downtown area, because of problems with loitering and transients.
2. Does allow alcohol in neighborhood parks where reservations of 50 or more are made for picnics.
3. Alcohol sold only by permit issued by the Bureau of Parks.

TIGARD

1. Alcohol is allowed with no restrictions if it is for the individuals own consumption.
2. OLCC Permit is required if alcohol is to be sold.

TUALATIN

Alcohol consumption is allowed. The only restriction is that the sale of alcohol is allowed only by OLCC Permit.

LAKE OSWEGO

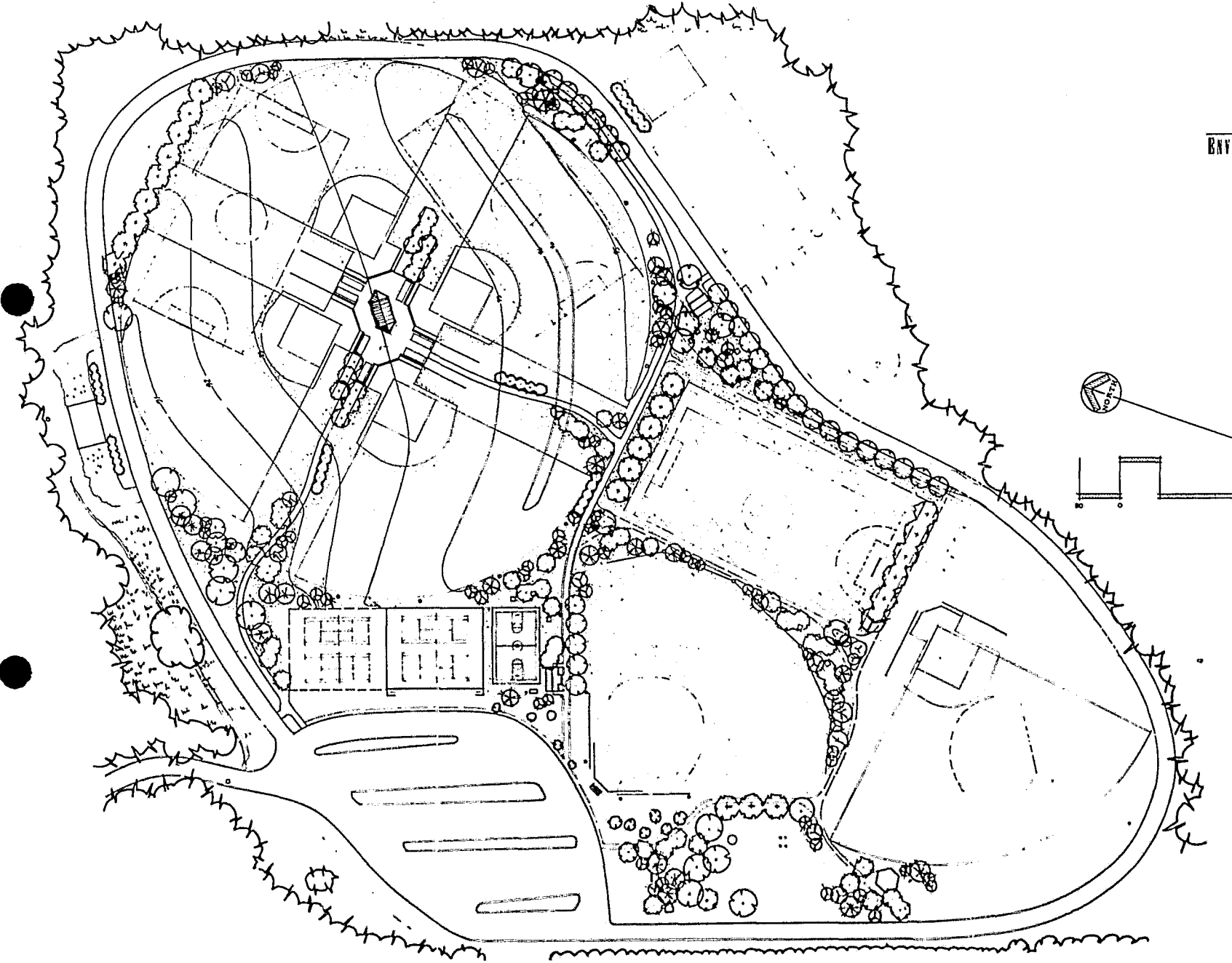
They do not allow alcohol in any of their parks. It is posted as such by City Ordinance.

MILWAUKIE

1. Alcohol is allowed with the restriction that container size must be less than one-quart.
2. Quart containers and containers over a quart, including kegs for dispensing are allowed by Park Permit in areas reserved by Private Parties e.g., family reunions, etc.
3. A permit from OLCC is required for the dispensing or sale of alcohol for any other purpose than as stated above, e.g., Company Parties, etc.

WEST LINN

Alcohol is allowed in City Parks, with the exception that NO kegs are allowed.
