#### ORDINANCE NO. 333

AN ORDINANCE EXTENDING WILSONVILLE ORDINANCE NO. 1 FOR A PERIOD NOT TO EXCEED 120 DAYS AND DECLARING AN EMERGENCY.

WHEREAS, Wilsonville Ordinance No. 1 granted an exclusive franchise to Portland General Electric to operate an electric utility for a period of twenty years to expire on October 10, 1988; and

WHEREAS, the City Council of the City of Wilsonville desires that city staff fully research electric utility franchises prior to adoption of a new franchise.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

Section 1. The terms of Wilsonville Ordinance No. 1 are hereby extended for a period not to exceed 120 days or no later than February 6, 1989.

Section 2. Whereas, it is necessary for the health, safety and welfare of the City of Wilsonville to have an electric utility franchise in effect at all times, an emergency is declared to exist and this ordinance shall be in full force and effect upon adoption by the City Council.

Our electric utility franchise with PGE was established under Ordinance No. 1. This ordinance was passed by the City Council on March 17, 1969 but had an effective date of October 10, 1968.

The franchise with PGE is one of our largest revenue generators for the general fund. The franchise fees for the past three years have been \$169,000, \$154,000, and \$168,000 respectively. PGE presented the city with a proposed new 20-year franchise on September 13th. This franchise agreement is almost exactly the same as the one passed by the Council 20 years ago.

Following receipt of that franchise we attempted to research any possible new developments in franchises. We ran into several stumbling blocks in this research. First, franchise agreements are not filed with the Oregon Public Utility Commission. Second, the League of Oregon Cities/Bureau of Governmental Research inquiry service did not have franchises on file. They were able to give me some leads on cities that they thought had negotiated franchises recently. We are in the process of making individual contact with those cities.

Given this lack of information, I believe it is premature to simply renew the franchise as presented for a 20-year period. The franchise may be acceptable in the form in which it was presented. However, I would like to be able to provide the Council with more indepth information upon which to base its decision than is currently available. The maximum of a 120-day extension will give us sufficient time to provide the Council with more information.

RECOMMENDATION: Adopt Ordinance CB-O-103-88 extending the PGE electric franchise for a period not to exceed 120 days.
