ORDINANCE NO. 409

AN ORDINANCE AUTHORIZING CITY MANAGER TO EXECUTE AMENDMENT TO STATE OF OREGON SPECIAL PUBLIC WORKS CONTRACT LOAN AND LOAN AND AUTHORIZING FUND INTERFUND LOAN TRANSFER FROM ROAD OPERATING FUND TO DEBT SERVICE FUND TO PAY DECEMBER 1, 1992 STATE LOAN PAYMENT FOR 95TH LOAN IMPROVEMENT PROJECT AND STAFF то INCLUDE REPAYMENTS DIRECTING FROM ASSESSMENTS FOR 95TH LOCAL IMPROVEMENT DISTRICT; AND **DECLARING AN EMERGENCY.**

WHEREAS, the City Council of the City of Wilsonville has previously authorized entering into a loan and loan contract with the State of Oregon to finance the construction of 95th Avenue Improvement Project pursuant to Ordinance No. 399 entitled "An Ordinance of the City of Wilsonville Authorizing a Loan From the Special Public Works Fund by Entering Into a Loan Contract With the Oregon Economic Development Department", enacted June 1, 1992; and

WHEREAS, the loan and loan contract, as well as other attending documents and certifications, were duly entered into by the respective parties; and

WHEREAS, the necessary requirements for public contracting for construction of the 95th Avenue improvement project were completed and the 95th Avenue project has been substantially completed with an official ribbon cutting ceremony scheduled for November 2, 1992; and

WHEREAS, a Local Improvement District No. 10 for the 95th Avenue construction project was duly formed and assessments against benefited property are to be made for project costs including, but not limited to, financing costs; and

WHEREAS, the first payment on the state loan is due December 1, 1992, in the sums of \$47,744.95 in interest and \$39,681.16 in principal for a total of \$87,426.11 and thereafter installment payments are called for annually each December 1, in the sum of \$135,171.05; and

WHEREAS, final costs will not be known until after December 1, 1992, and corresponding assessments, which shall be semi-annual payments, will not commence until after December 1, 1992; and

WHEREAS, the project is far enough along to know that preliminary construction costs and financing costs along with other project costs will be less than the loan proceeds by an amount sufficient to allow loan proceeds to be applied to the December 1, 1992 interest payments of \$47,744.95 and also to provide for unexpended funds, which under the loan contract, Section 3.08, may be used to prepay the rate plus any arbitrate rebate due as of January 1, 1995; and

WHEREAS, while the loan contract can be amended to apply loan proceeds to the December 1, 1992 interest payment of \$47,744.95, it cannot be amended as to the principal payment of \$39,681.16; therefore, it is financially prudent for the City Council to authorize its City Manager to execute the appropriate amending documents to allow the loan proceeds to be applied to the December 1, 1992 interest payment of \$47,744.95 and to authorize the Finance Director to make a loan from the Road Operating Fund, to the Debt Service Fund, to pay the December 1, 1992 principal payment of \$39,681.16, and to instruct staff to appropriately provide in the assessments the amounts to cover the interest payment of \$47,744.95 and the repayment to the City of the principal payment of \$39,681.66.

NOW, THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

1. The City Manager is authorized to execute the documents necessary to amend the Special Public Works Loan and Loan contract with the State of Oregon Economic Development Department to pay the December 1, 1992 loan interest payment in the sum of \$47,744.95 from the Special Public Works Fund loan proceeds.

2. The Finance Director is authorized to make a loan from the Road Operating Fund, to the Debt Service Fund, in the sum of \$39,681.16 in order to pay the December 1, 1992 principal payment on the Special Works Fund Loan. The interfund loan is to be repaid to the Road Operating Fund by June 30, 1993, and if any part is not repaid, it shall be budgeted in the ensuing year.

3. Staff is directed to include in the assessments for the Local Improvement District No. 10 95th Avenue Project costs, cost amounts for the interest payment of \$47,744.95 and to repay the City for the principal payment of \$39,681.66 and any financing costs associated with the City's advancing the principal amount.

4. That it is determined by the Wilsonville City Council that time is of the essence and an emergency exists and that this Ordinance shall take effect immediately upon final reading and passage by the Council.
