#### ORDINANCE NO. 410

AN ORDINANCE ASSESSING BENEFITED PROPERTY FOR THE COSTS OF CONSTRUCTING LOCAL IMPROVEMENT DISTRICT PROJECT NO. 10, KNOWN AS THE 95TH AVENUE ROAD EXTENSION AND FREEMAN DRIVE ADDITION, DIRECTING THE CITY RECORDER TO ENTER THE ASSESSMENTS IN THE DOCKET OF CITY LIENS, AND DECLARING AN EMERGENCY.

#### THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

#### 1. THE COUNCIL FINDS:

- 1.1 The Local Improvement District No. 10 project known as the 95th Avenue extension and Freeman Drive addition was constructed by authority of Resolution No. 766, accepting written petition from 100% of the benefited property owners for formation of L.I.D. No. 10, adopted April 2, 1990; Resolution No. 777, approving engineer's report and financial investigation report, adopted July 2, 1990; Resolution No. 782, declaring the City's intent to proceed with L.I.D. #10, adopted July 16, 1990; Resolution No. 904, including Freeman Drive improvements in L.I.D. #10 as special benefit to tax lot 1300 (formerly part of tax lot 1802) and tax lot 1903; approving Oregon Department of Economic Development Loan Financing for L.I.D. #10 and providing for repayment through specially assessing benefited properties, adopted April 6, 1992.
- 1.2 The Council has accepted and approved a certification of completion of the project. Final costs include contractor payments, advertising, progress payment interest, right-of-way acquisition, design and inspection engineering, legal fees, superintendence and administration, and financing costs associated with borrowing through the Oregon State Department of Economic Development Special Public Works Fund Loan to pay design and construction costs inclusive of repaymentinte, rest, legal fees, and associated fees.
- 1.3 The whole cost of the improvement is \$1,337,000.00. The property owners' share is \$1,337,000.00.

- 1.4 The project is consistent with the level of service contained in the City's Transportation Master Plan and Comprehensive Plan.
- 1.5 Each parcel of land within local improvement district receives special and peculiar benefits from the project as set forth as follows:

- 1.6 The City Recorder has notified property owners of the assessment hearing conducted by the City Council, the rights and manner to object to the proposal, and the amount of the proposed assessment on benefited property set forth above.
- 1.7 The Council has considered the proposed assessments and all objections made by owners of benefited property.
- 1.8 The final assessments set forth above are for a capital construction local improvement, instituted and incurred at the request and for the benefit of all the property owners, and are not subject to property tax limitation established by Article XI, Section 11b of the Oregon Constitution.
- 2. NOW, THEREFORE, THE COUNCIL DIRECTS:
  - 2.1 The final assessment roll recited above for each of the special and peculiarly benefited properties is hereby adopted and approved;
  - 2.2 The City Recorder is to enter the assessments in the Docket of City Liens;
  - 2.3 The City Recorder is to mail final assessment notices to all owners of benefited property as described in the recital above;

- 2.4 Installment payments shall be calculated based on the costs of the Special Public Works Fund Loan of 6.32% per annum, together with the administrative costs to pay financing and loan processing fees of .5% of the benefited property owners' loan amount, for a total interest charge of 6.82%;
- 2.5 The Finance Director is authorized to collect a pro rata interest charge of five percent (5%) for any assessment prepayment in order to fund a ratable portion of the City's debt service obligations under the State loan contract for early payment;
- 2.6 That in order to insure timely payment on the underlying Special Public Works Fund Loan, time is of the essence, and an emergency is hereby declared and this ordinance is to take effect immediately upon its passage.

SUBMITTED to the Wilsonville City Council for first and second reading at a regular meeting thereof on the 19th day of January, 1993, commencing at the hour of 7:00 P.M. at the Wilsonville Community Development Hearings Room.
