ORDINANCE NO. 486

AN ORDINANCE GRANTING TO NORTH WILLAMETTE TELECOM A SIXMONTH EXTENSION OF THE DEADLINE TO COMPLY WITH SECTION
12(A)(2) OF ORDINANCE NO. 434, "AN ORDINANCE GRANTING NORTH
WILLAMETTE TELECOM, INC., AN OREGON CORPORATION, A FRANCHISE
TO OPERATE A COMPETITIVE TELECOMMUNICATIONS BUSINESS
WITHIN THE CITY OF WILSONVILLE AND TO PLACE, ERECT, MAINTAIN,
LAY AND OPERATE IN, UPON, OVER AND UNDER THE PUBLIC RIGHTS OF
WAY NECESSARY WIRES AND OTHER APPLIANCES FOR
COMMUNICATIONS PURPOSES WITHIN THE CITY OF WILSONVILLE."

WHEREAS, the Wilsonville City Council in 1994 approved Ordinance No. 434, granting to North Willamette Telecom, Inc., a non-exclusive franchise to operate a competitive telecommunications business within the city; and

WHEREAS, Section 12(A)(2) reserves to the city the right to cancel said franchise if North Willamette Telecom "fails to complete construction of an initial telecommunications system within 36 months of the effective date of this franchise;" and

WHEREAS, North Willamette Telecom has under construction within the city its initial telecommunications system; and

WHEREAS, the initial portion North Willamette Telecom's telecommunications system may not be complete by September 19, 1997; and

WHEREAS, the City Council of the City of Wilsonville does not wish to terminate said franchise with North Willamette Telecom, Inc.

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF WILSONVILLE ORDAINS AS FOLLOWS:

1. North Willamette Telecom, Inc., an Oregon corporation, is hereby granted a six-month extension of the deadline contained in Section 12(A)(2) of Ordinance No. 434, said extension to expire on March 19, 1998.
