

RESOLUTION NO. 1684

A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE NOVEMBER 7, 2000 GENERAL ELECTION.

WHEREAS, at the General Election held November 7, 2000, the electorate of the City of Wilsonville cast ballots for Mayor and two City Councilor positions; and

WHEREAS, Ballot Measure 3-92 which authorizes the issuance of general obligation bonds for the Wilsonville Public Library expansion also was voted upon during the November 7, 2000 General Election; and

WHEREAS, the terms of Mayor and of the City Council positions are four-year terms, and

WHEREAS, the general election of the registered voters of Clackamas County was conducted by mail; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally for Clackamas County was duly received by the City Recorder on November 27, 2000; and from Washington County was duly received by the City Recorder on November 29, 2000, copies of which are attached hereto and incorporated by reference.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

2. Based upon the adopted canvass of votes, the City Council affirms that John Helser and Benny Holt have each been elected to the position of City Councilor for a four-year term beginning January 1, 2001.

3. Ballot Measure 3-92 which authorizes the issuance of general obligation bonds for the Wilsonville Public Library expansion has passed having received the affirmative majority of the legal voters cast on Ballot Measure 3-92 and entitled to be counted thereon.

4. The City Recorder shall file the Certificates of Election in accordance with the above.
