## **RESOLUTION NO. 1829**

A RESOLUTION REDUCING CERTAIN WATER RATES EFFECTIVE JUNE 1, 2003 AND AMENDING TABLE II OF RESOLUTION 1713.

WHEREAS, water rates were established by Resolution 1624 on March 20, 2000 and later amended by Resolution 1713 on June 18, 2001; and

WHEREAS, under Resolution 1713 Block 2, the highest rate, was designed to be the residential irrigation rate; and

WHEREAS, both Resolutions 1624 and 1713 maintained a high irrigation rate intended to discourage the use of water for irrigation; and

WHEREAS, the completion of the water treatment plant has solved the community's immediate water shortage problem; and

WHEREAS, nearly a year has elapsed since the completion of the plant and operating costs are more accurately determined and water consumption has been greater than during the similar period in the preceding year; and

WHEREAS, Resolution 1713 provided for a rate review after completion of the water treatment plant and determination of electricity costs; and

WHEREAS, Debbie Galardi of Galardi Consulting and CH2M Hill, the City's consulting rate expert, has determined that a 5% decrease in irrigation rates and an increase of one unit in the residential base rates should provide sufficient revenues to meet current financial obligations of the water operating fund; and

WHEREAS, staff recommends that the new rate table be made effective June 1, 2003; and

WHEREAS, full and complete operating costs and customer consumption patterns are subject to change and a re-determination of rates may be necessary after another year of operation.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. That Table II, City of Wilsonville Water Use Fees in Resolution 1713 shall be replaced by the updated Table II, City of Wilsonville Water Use Fees Effective June 1, 2003, a copy of the revised Table II is attached hereto as Exhibit A and incorporated as if fully set forth herein.
