

RESOLUTION NO. 1851

A RESOLUTION ACKNOWLEDGING THE CERTIFICATION OF THE ELECTION RESULTS OF THE SPECIAL SEPTEMBER 16, 2003 ELECTION BY THE CITY RECORDER THE CITY'S ELECTION OFFICIAL.

WHEREAS, at the Special Election held September 16, 2003, the electorate of the City of Wilsonville cast ballots for Ballot Measure 3-107, An Advisory Vote on formation of a new West Side Urban Renewal District; and

WHEREAS, the election of the registered voters of Clackamas County was conducted by mail; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally for both Clackamas and Washington counties was duly received by the City Recorder on October 6, 2003, copies of which are attached hereto and incorporated by reference.
