RESOLUTION NO. 1902

A RESOLUTION OF THE CITY OF WILSONVILLE ACTING THROUGH ITS SOUTH METRO AREA RAPID TRANSIT DEPARTMENT, HEREINAFTER REFERED TO AS SMART, AUTHORIZING THE PURCHASE OF FOUR 21 PASSENGER CHAMPION CHALLENGER BUSES AND ASSOCIATED EQUIPMENT FROM WESTERN BUS SALES, INC.

WHEEREAS, the City of Wilsonville has adopted and copywrited the name South Metro Area Rapid Transit, hereinafter referenced as "SMART" for its department of transportation; and

WHEREAS, based on Federal Transit Administration useful life standards four buses in SMART's current fleet have exceeded these standards; and

WHEREAS, SMART has received a grant from the Oregon Department of Transportation to provide 89.73% of the funding to purchase replacement buses; and

WHEREAS, the grant from the Oregon Department of Transportation and the proposed purchase of four buses is included in the approved fiscal year 2005 budget for the City of Wilsonville; and

WHEREAS, SMART has completed the Request for Proposals (RFP) process in accordance with all city, state, and federal procurement requirements that guarantee open and fair competition; and

WHEREAS, SMART has awarded the bid to Western Bus Sales, Inc. in accordance with the terms defined in the RFP and;

WHEREAS, Western Bus Sales, Inc supplied the lowest responsive bid amount at \$61,315 per bus (base unit cost) and \$53,720 per bus (including all scheduled options) as identified in Exhibit A; and

WHEREAS, SMART has chosen to purchase four buses that with selected options total \$255,092 (\$63,773 each).

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- Based on the above recitals incorporated herein, the City Council, acting as the Local Contract Review Board, does hereby approve and authorize SMART acting on behalf of the City of Wilsonville to submit a Purchase Order for the purchase of four 21passenger Champion Challenger buses and associated equipment to Western Bus Sales, Inc.
- 2. Authorize the expenditures for this purchase not to exceed the total FY 2004/05 amounts as budgeted or amended from:

Budget Amount \$303,852.00

3. This resolution is effective upon adoption.
