RESOLUTION NO. 1932

A RESOLUTION OF THE CITY OF WILSONVILLE EXCHANGING AND ADOPTING EASEMENTS, GO DUCKS LLC, GRANTOR.

WHEREAS, the City of Wilsonville Design Review Board approved the Stage II development of The Honda Dealership, 03DB27, which required as a condition of approval that a public utility easement be conveyed to the City; and

WHEREAS, there currently exists on the property an easement recorded as Fee No. 72-29509 and dated September 28, 1972. However, the location of this easement does not meet the requirements of the easement described above. Furthermore, the existing easement does not conform to the needs and requirements of the Public Works Department and, therefore, said easement is no longer needed by the City of Wilsonville; and

WHEREAS, the City Council finds that the existing above referenced real property easement is being exchanged pursuant to ORS 271.310(3) for a real property easement which is of equal or superior useful value for public use for the City's sewer lines; therefore, extinguishment by vacation is unnecessary.

NOW, THEREFORE THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. Based on the above recitals and findings, the City of Wilsonville adopts the following exchange of easements:
- (a) The City's release, by a Reconveyance and Quitclaim, of all its interest in the Sanitary Sewer Easement described in Exhibit 1, attached hereto and incorporated herein, in exchange for
- (b) Go Ducks LLC's conveyance to the City of the Sanitary Sewer Pipeline Easement described in Exhibit 2, attached hereto and incorporated herein.
 - 2. The City Manager is authorized to sign these instruments on behalf of the City.
 - 3. This resolution is effective upon adoption.


