A RESOLUTION OF THE CITY OF WILSONVILLE CITY COUNCIL IN SUPPORT OF THE SCHOOL BOUNDARY ADJUSTMENT BETWEEN THE WEST LINN – WILSONVILLE SCHOOL DISTRICT AND THE SHERWOOD SCHOOL DISTRICT.

WHEREAS, the city of Wilsonville approved the Villebois Village Master Plan to create an urban village of approximately 2,300 residences on 481± acres; and

WHEREAS, 393± acres of Villebois Village is within the West Linn-Wilsonville School District and the remaining 85.4 acres is within the Sherwood School District along with 27.8 acres immediately east of the Villebois Village site as shown in Exhibit 1; and

WHEREAS, less than 60 of the 85.4 Sherwood School District acres in Villebois Village are developable, and none of the 27.8 acres to the east of Villebois Village are developable; and

WHEREAS, the Sherwood School District Board of Directors and the West Linn-Wilsonville School District Board of Directors have mutually agreed to transfer the 113± acres noted above and described in Exhibits 1 and 2 from the Sherwood School District to the West Linn-Wilsonville School District, effective immediately; and

WHEREAS, there are three other miscellaneous boundary adjustments that the Sherwood School District Board of Directors and the West Linn-Wilsonville School District Board of Directors have mutually agreed are needed to create a clearer boundary between the two school districts:

- 78.44 acres identified as area near Bell Road and described in Exhibits 1 and 2 to be transferred from the West Linn-Wilsonville School District to the Sherwood School District, effective immediately.
- 16.35 acres identified as Argyle Square and described in Exhibits 1 and 2 to be transferred from the West Linn-Wilsonville School District to the Sherwood School District, effective on July 1, 2008.
- 5.27 acres identified as Whittaker Property and described in Exhibits 1 and 2 to be transferred from the Sherwood School District to the West Linn-Wilsonville School

District, effective immediately; and

WHEREAS, the Board of Directors for the two school districts approved the boundary adjustment by resolution (Exhibits 3 and 4); and

WHEREAS, the proposed transfer of properties would serve the educational interests of the school-age children residing therein.

NOW, THEREFORE, THE WILSONVILLE CITY COUNCIL RESOLVES AS FOLLOWS:

- 1. The Council fully supports the proposed adjustment between the Sherwood School District and the West Linn-Wilsonville School District boundary as shown in the Exhibits and as described herein.
 - 2. This resolution becomes effective upon adoption.


