

RESOLUTION NO. XXVII

A RESOLUTION AUTHORIZING EXECUTION OF CONTRACT FOR CONSTRUCTION OF CONCRETE FOUNDATION RING AND GRANULAR PAD FOR WATER STORAGE TANK.

WHEREAS, the qualified legal voters of the City of Wilsonville approved a Charter Amendment at a special City Election duly and legally called and held on August 18, 1969, for the purpose of authorizing the issuance and sale of general obligation bonds of the City in the sum of \$650,000 for the construction, ownership and operation of a City water utility system; and

WHEREAS, The Wilsonville City Council has proceeded to issue and sell the bonds authorized for the said purposes and employed W. J. Dorner, Consulting Engineer, of Portland, Oregon, to prepare the plans and supervise the construction of a concrete foundation ring and granular pad for a 2.2 MG. steel water storage tank, which is one phase of the City's water utility facility. Bids for this phase of the project were publicly called for the time and in the manner required by law, and received and publicly opened by the City Council on February 28, 1972; and

WHEREAS, the bids received for the construction of said concrete foundation ring and granular pad were examined by the City Council and W. J. Dorner, their engineer, and the lowest which was also an acceptable bid was that of Riverside Construction Co. of Milwaukie, Oregon, whose base bid was a total of \$6,725.00; and

WHEREAS, the said bidder is ready, willing and able to proceed with the construction contract in accordance with the plans, specifications and proposal for the said project, and it is necessary that a formal written contract be approved and executed by Riverside Construction Co. and the City, now, therefore,

BE IT RESOLVED by the Common Council for the City of Wilsonville, Clackamas and Washington Counties, Oregon, that the bid proposal of Riverside Construction Co. for the construction of the City's concrete foundation ring and granular pad for a 2.2 Mg.


steel water storage tank, according to the plans and specifications for said project prepared by W. J. Dorner, Consulting Engineer, of Portland, Oregon, and for the total contract amount of \$6,725.00 is hereby approved and accepted; and the Mayor and City Recorder are hereby authorized and directed to make, execute and deliver in the name of and on behalf of the City of Wilsonville, an appropriate construction contract with the said Riverside Construction Co.; and the construction costs and charges for said contract shall be paid upon receipt of billings and approval by the City's engineer and the City Council from the proceeds of the sale of the City's water bonds.
