

RESOLUTION NO. CXXIX (129)

A RESOLUTION DECLARING INTENTIONS TO PROCEED WITH THE CONSTRUCTION OF KINSMAN ROAD IMPROVEMENTS IN KINSMAN ROAD IMPROVEMENT DISTRICT (LID #4); ADOPTING ENGINEER'S REPORT AS FILED AND DIRECTING THE PREPARATION OF DETAILED PLANS, SPECIFICATIONS AND COST ESTIMATES.

WHEREAS, a public hearing for remonstrances on the engineer's report and plans for construction of Kinsman Road as requested by property owners in the area of the city previously designated as KINSMAN ROAD LOCAL IMPROVEMENT DISTRICT (LID #4) by Council Resolution No. CXXVI (126) adopted September 4, 1979, was duly and regularly called, advertised and held by the Wilsonville City Council on October 1, 1979; and

WHEREAS, there were no objections made by the owners of the property in the area to be assessed and all who appeared at the hearing gave unanimous approval to proceed with the improvement project and there were no written objections or remonstrances filed before, during or after the hearing by anyone; and

WHEREAS, the Council considered the matter and the engineer's report, and unanimously agreed that the improvement project should proceed and for assessment of a proportional share of the costs to the benefited properties within the boundaries of said district; and that detailed plans, specifications and cost estimates should be prepared by the City's engineer after it has received for the City necessary easements and/or deeds of dedication for the road area to be improved, or has otherwise received irrevocable commitments from property owners to grant to the City necessary easements and/or deeds for Kinsman Road; now therefore, it is hereby

RESOLVED that the City proceed with the project for the construction of street improvements including street construction, drainage facilities, underground power and telephone facilities, water lines and street lighting, in that area of the City previously

described and designated in this matter as the KINSMAN ROAD LOCAL IMPROVEMENT DISTRICT (LID #4); that the report on this project by Westech Engineering, Inc., consulting engineers and planners of Salem, Oregon, as filed with the City on July 31, 1979, and modified and amended by the Council on August 6, 1979, is now adopted as amended. Furthermore, the said engineering firm is hereby authorized and directed to prepare detailed plans, specifications and cost estimates for the improvement project after it has received on behalf of the City necessary easements and/or deeds for dedication to the City of said road, or has received irrevocable commitments from property owners for grants of necessary easements or deeds for dedication of the road to the City for the construction of this improvement project.
