

RESOLUTION NO. CXXXI (131)

A RESOLUTION TO ACCEPT JURISDICTION OF STREETS IN THE "OLD TOWN" AREA OF THE CITY OF WILSONVILLE FROM CLACKAMAS COUNTY

WHEREAS, Clackamas County has jurisdiction of five (5) county roads hereinafter described which are within the city limits of Wilsonville; and

WHEREAS, the Clackamas County Board of Commissioners have agreed to accept and pay the City's cost overrun on the Wilsonville Road Project if the Wilsonville City Council will accept jurisdiction of five (5) county roads which are within the city limits; and

WHEREAS, Clackamas County has made the City's acceptance of said county roads as hereinafter described the basis of its offer for financial participation on the City's Wilsonville Road Project; NOW THEREFORE:


BE IT RESOLVED that the City Council of Wilsonville, Clackamas and Washington Counties, Oregon, request jurisdiction from Clackamas County as provided for in ORS 371.270 of the following county roads which are within the city limits of Wilsonville:

1. County Road No. 2206, 5th Street, being adjacent to and southerly of Blocks A and B and that portion of Magnolia Avenue included within 5th Street, located in the Plat of Wilsonville, a townplat recorded in Book 7, on page 27, and also all of 5th Street as shown in the Plat of Extension of 5th Street, Wilsonville, a townplat recorded in Book 11, Page 18, Record of Townplats for Clackamas County, Oregon. Said road known as Nutting Road having 60 feet of dedicated right-of-way and being 1,900 feet in length.
2. County Road No. 2702, Magnolia Avenue in the Plat of Wilsonville Plat No. 196 in Section 23, Township 3 South, Range 1 West of the Willamette Meridian.
3. County Road No. 2703, Fir Avenue in the Plat of Wilsonville Plat No. 196, in Section 23, Township 3 South, Range 1 West of the Willamette Meridian. Excluding that portion vacated lying north of 5th Street between the east half of Block 8 and Tax Lots 5 and 18 in the Thomas Baily DLC.
4. County Road No. 2704, being all that portion of 4th street extending from Market Road No. 27 (Main Street) east to the westerly boundary of Fir Avenue as shown by Wilsonville Plat No. 196.
5. County Road No. 0150, Boones Ferry Road from 5th Street to the Willamette River;


and

BE IT FURTHER RESOLVED that the acceptance of the above described roads as city streets is in the best interest of the City and the Wilsonville City Council will accept jurisdiction of said roads/streets upon entry of a final order by the Clackamas County Board of Commissioners on the understanding and condition that said Board will assume and pay the City's cost overrun on the "Wilsonville Road Project".
