

RESOLUTION NO. CXLVIII (148)

A RESOLUTION TO AUTHORIZE CONSTRUCTION CONTRACT WITH K & R PLUMBING CONSTRUCTION FOR A STORM SEWER OUTFALL DRAINAGE SYSTEM.

WHEREAS, the City of Wilsonville has heretofore advertised for and received bids which were publicly opened at the City Hall on October 2, 1980, for construction of a storm sewer outfall drainage system for the Day Dream Ranch project; and

WHEREAS, the plans and specifications for said project were prepared by Wilsey & Ham Engineers, Inc. of Portland, Oregon and approved by the City of Wilsonville, and calls for bids were duly and regularly published in the manner and for the time required by law; and

WHEREAS, bids were publicly opened and read aloud at the Wilsonville City Hall on October 2, 1980, and the results of the bidding were reported to the Mayor and Wilsonville City Council by memorandum of Larry Blanchard, Public Works Director of the City, dated October 6, 1980, and said memorandum and bids were considered by the Wilsonville City Council at its regular meeting on Monday, October 6, 1980. There were a total of three (3) bids received as follows:

WHEREAS, the Wilsonville City Council/Contract Review Board has considered the bids, the plans and specifications for said project, the contract documents generally, and the reports and recommendations of its Public Works Director and determined that the low bid is that of K & R Plumbing Construction for the bid amount of \$14,229.43,


NOW, THEREFORE, BE IT RESOLVED by the Wilsonville City Council that:

1. The bid of K & R Plumbing Construction for construction of a storm sewer outfall drainage system in the total amount of \$14,229.43, as set forth by the City's Director of Public Works, in his memorandum to the Mayor and the City Council dated October 6, 1980, is hereby accepted for the amount of the contract for the construction of said project according to the plans and specifications as prepared by Wilsey & Ham Engineers, Inc. of Portland, Oregon.

2. The Mayor and City Recorder are authorized and directed to make, execute and deliver in the name of the City of Wilsonville, and on its behalf, a contract with K & R Plumbing Construction for construction of a municipal storm sewer outfall drainage system to the plans and specifications therefor, and any changes or modifications of those plans and specifications as may be approved by the City Council and which said plans and specifications are now on file in the office of the City Recorder.


3. Payment by the City of Wilsonville of the construction contract authorized by the foregoing Section 2 is to be made according to the schedule for payments as outlined in the contract documents.

4. In order that the construction work for the improvement project be commenced prior to the rainy season and resulting outfall problem, an emergency is hereby declared to exist and this resolution was adopted by the Wilsonville City Council/Contract Review Board by this written resolution at its regular meeting on the 20 th day of October, 1980.
