SUBJECT: Accept Bid Memorial Park Sewer Line

Sealed bids were opened at 2:00 pm Friday, May 14, 1982, for the construction of the sanitary sewer line in Memorial Park. Nine bids were received and the top 4 bids had a low-high spread of \$337.50 which indicates very competitive bidding.

The total estimate done for the project in March 1981 was \$5,700.00. The total estimate done in February 1982 indicated a construction price of \$7,000 with a recent estimate set at \$7,200.00. The low bid by Bones Construction at \$7,295.00 is only 1.3% higher than the most recent estimate.

Bones Construction has just recently completed the Old Town Storm Sewer -Sanitary Sewer Improvement Project. Even-with the difficulty of construction in an existing residential area Bones Construction did the job as administered by the City of Wilsonville.

Recommendation

Accept the low bid of \$7,295.00 from Bones Construction for the Memorial Park Sanitary Sewer Line as designed and specified by staff and Westech Engineering Inc.
