A RESOLUTION RATIFYING THE PROCESS AND AUTHORIZING THE SIGNING OF AN APPLICATION TO THE SECRETARY OF STATE REQUESTING THAT THE CONSTITUTIONAL AMENDMENT IN PARAGRAPH 2 OF ENROLLED SENATE JOINT RESOLUTION 30 (1983 FIRST SPECIAL SESSION) BE PLACED ON THE BALLOT IN THE MANNER STATED IN THE SENATE JOINT RESOLUTION 30 (1983 FIRST SPECIAL SESSION)

WHEREAS, The Legislative Assembly of the STATE OF OREGON has caused Senate Joint Resolution 30 (1983 First Special Session) to be enacted, and

WHEREAS, the SENATE JOINT RESOLUTION 30 (1983 First Special Session) has a requirement that a majority of all of the cities, all of the counties, and all of the school districts, including community colleges, together representing a majority of the population of the state, request by application to the Secretary of State that the Constitutional Amendment in Paragraph 2 of Enrolled Senate Joint Resolution 30 (1983 First Special Session) be placed on the ballot at an election as specified in Paragraph 3 of Enrolled Senate Joint Resolution 30 (1983 First Special Session), and

WHEREAS, Notice of a Public Hearing has been given and a Public Hearing has been held on the question of placing Paragraph 2 of the Enrolled Senate Joint Resolution 30 (1983 First Special Session) on the ballot for an election, and interested parties, if any, have had an opportunity to be heard on the subject, and

WHEREAS, the City Council of the City of Wilsonville is desirous of taking action on the issue.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Wilsonville does hereby ratify the process and authorize the signing of the application by each member of the Council addressed to the Secretary of State requesting that the Constitutional Amendment in Paragraph 2 of Enrolled Senate Joint Resolution 30 (1983 First Special Session) be placed on the ballot at an election as specified in Paragraph 3 of Enrolled Senate Joint Resolution 30 (1983 First Special Session) and further directing that the signed application be submitted to the Secretary of State.
