APPROVAL OF THE QUALIFIED LOW BID SUBMITTAL; AND AWARDING THE CONTRACT TO ASSOCIATED LANDSCAPING AND SUPPLY, FOR

THE LANDSCAPING AND IRRIGATION OF CITY HALL.

On March 14, 1984, the City Council approved a resolution approving the plans and specifications and authorizing staff to advertise to receive sealed bids for the construction of Wilsonville City Hall landscaping, irrigation and grading. Subsequently, on April 2, 1984, a resolution was passed amending the plans and specifications.

Bids opening was held on April 11, 1984. The City of Wilsonville received bids by eight landscape architects with the following results:

*NOTE: Al Teufel's original bid did not include fumigation which increases his lump sum from \$26,417 to \$35,167.

Therefore, after meeting with Associated Landscaping concerning the plans and specification as they relate to the bid proposal, the Planning staff finds that the bid of Associated Landscaping is the lowest qualified bid.

Upon approval of this bid, Associated Landscaping shall execute a contract within fifteen (15) days (Sundays excepted) from the date of notification and shall complete the work covered by the contract within ninety (90) calender days after formal notice to proceed.

Lastly, all other bid bonds shall be returned to the remaining contractors after the construction contract has been signed.
