RESOLUTION NO. 418

A RESOLTUION DECLARING THE INTENTION TO PROCEED WITH THE CONSTRUCTION OF THE PARKWAY AVENUE REALIGNMENT AND ELLIGSEN ROAD IMPROVEMENT PROJECT, HEREINAFTER REFERRED TO AS LOCAL IMPROVEMENT DISTRICT NO. 9 (L.I.D. #9); AUTHORIZING STAFF TO APPROVE THE FINAL DETAILED PLANS AND SPECIFICATIONS AS PRESENTED BY DAVE EVANS AND ASSOCIATES; AUTHORIZING STAFF TO ADVERTISE TO RECEIVE SEALED BIDS; ACCEPTING DEDICATED RIGHT-OF-WAY AND UTILITY EASEMENTS REQUIRED TO CONSTRUCT L.I.D. # 9; APPROVING THE PREPAYMENT TO PORTLAND GENERAL ELECTRIC FOR ELECTRICAL AND STREET LIGHT INSTALLATIONS; ESTABLISHING THE BOARD OF VIEWERS FOR L.I.D. #9; AUTHORIZING STAFF TO PROCEED FORWARD WITH PRELIMINARY ASSESSMENT AND ESTABLISH A PUBLIC HEARING DATE AND TIME FOR SAID PRELIMINARY ASSESSMENT.

WHEREAS, on July 5, 1983, at 7:30 o'clock p.m. in the City Council Chambers at City Hall, 30000 S. W. Town Center Loop East, the City Council did approve Resolution No. 337, titled, "A RESOLUTION ADOPTING THE ENGINEER'S REPORT FOR PARKWAY AVENUE REALIGNMENT AND ELLIGSEN ROAD IMPROVEMENT PROJECT (L.I.D. #9); DECLARING THE FORMATION OF THE IMPROVEMENT DISTRICT; DEFINING THE SCOPE OF SAID IMPROVEMENTS; SETTING A PRELIMINARY ASSESSMENT FORMULA; AUTHORIZING THE CITY'S ENGINEER TO PREPARE DETAILED PLANS AND SPECIFICATIONS FOR BID ADVERTISEMENT"; and

WHEREAS, staff has received detailed final construction plans and specifications and find them to be in compliance with the Wilsonville Code, Capital Improvement Plan, Public Works Standards, Planning Commission Resolution Approving the Realignment of Parkway Avenue, and all applicable rules and regulations pertaining to Public Works Construction in the City

of Wilsonville; and

WHEREAS, upon satisfaction that the preliminary assessments are completed, and the bond sale has been substantially processed as determined by the City Administrator, staff shall be authorized to proceed with the advertisement to receive sealed bids for the L.I.D. #9 Project; and

WHEREAS, staff shall proceed forward with the preliminary assessments for L.I.D. #9 and in order to do so, the City Council must appoint three (3) members to the Board of Viewers as established in Section 3.210 of the Wilsonville Code, with all three (3) members being residents of the City of Wilsonville; and

WHEREAS, attached hereto and further referenced herein as Exhibit "1", the City hereby acknowledges and accepts the dedicated right-of-way, subject to approval of the City's engineer and the City's attorney for the streets in L.I.D. #9 for Parkway Avenue Realignment, all utilities shall be constructed in easements which have already been presented to the City. Elligsen Road Improvements are to be constructed within existing right-of-way that are within City jurisdiction; and

WHEREAS, upon advertisement to receive sealed bids for L.I.D. #9
the City shall authorize staff to approve the attached agreements with
Portland General Electric herein referenced as Exhibit "2" for the prepayment
of \$46,118.01 for electrical installations, and complete those improvements
necessary to install street lights for L.I.D. #9, said street light
improvements shall be included in the Arterial Street Lighting District; and

WHEREAS, the City Council shall establish the date and time for the Board of Viewers to meet to finalize the preliminary assessments for L.I.D. #9, which will be completed as specified in Section 3.210 of the Wilsonville Code.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Wilsonville, that:

- The City intends to proceed forward with the construction of Parkway Avenue Realignment and Elligsen Road Improvement (L.I.D. #9) as stipulated in this resolution.
- 2. The City authorizes staff to approve the final plans and specifications for L.I.D. #9 according to all City, County, State and Federal codes, requirements, rules and regulations governing public works construction in the City.
- 3. The City shall authorize staff to receive sealed bids for the construction of L.I.D. #9 by approval of the City Administrator once the assessment and bonding process is to the point where such approval can be given.
- 4. The City accepts the dedicated right-of-way, subject to approval of the City's engineer and the City's attorney, as herein referenced in Exhibit "1" for the street right-of-way for the Parkway Realignment.
- 5. The City appoint three (3) Wilsonville residents, namely Bob Cruccholia, Don Carlson and Bob Dant, to the Board of Viewers, and establish a date, place and time for a meeting to finalize the preliminary assessment formula.

- 6. The City approve the prepayment of \$46,118.01 to Portland General Electric for the electrical installation for L.I.D. #9 and authorize the Mayor to sign the agreements for street light installations as stipulated in Exhibit "2" and as mentioned hereinbefore in this resolution.
- 7. The City Council set the date for the Public Hearing to be held on Tuesday, September 4, 1984, at a regular City Council meeting.

This letter will outline the division of responsibility between the City of Wilsonville and Portland General Electric for the underground electrical distribution system (backbone only) for Parkway Center LID #9.

As you are aware, developers of subdivisions or other large projects are required to make a cash advance for the cost of the line extension. The line extension charge for this project is \$46,118.01. The terms of this agreement remain in effect provided our work is completed within 6 months. When permanent customers are connected, refunds will be made to the city in accordance with the tariff based on the various rate schedule allowances.

THE CITY OF WILSONVILLE LID #9 (PARKWAY CENTER) WILL BE RESPONSIBLE FOR:

- 1. Providing and installing all vaults, conduits, non-conductive pull lines and necessary trench in accordance with PGE Job #6743.
- 2. Provide all necessary easements.
- 3. Pay line extension costs (\$46,118.01).
- 4. Install the street bore under SW Elligsen Rd.
- 5. Provide and install the Brooks 40 fiberglass junction boxes and conduits (Option A, Streetlighting). Gordon Utter, PGE Streetlighting Consultant, will address this further in a forthcoming letter.

Larry, the streetlighting proposal for City of Wilsonville LID-9 calls for 20 - 200 watt, 22,000 lumen high pressure sodium roadway luminaires mounted on 10 - 30-foot aluminum double-davit poles and 9 - 200 watt, 22,000 lumen high pressure sodium roadway luminaires mounted on 9 - 30-foot aluminum single-davit poles. A sketch showing the streetlight locations is attached.

Grantee will indemnify and hold Grantors, their heirs and assigns harmless from any and all claims for injury to persons or property as a result of any of the activities of Grantee, its agents or employees in the construction, operation or maintenance of said equipment or facilities.

All construction, installation or use by the Grantee shall be underground except for ground-mounted transformers, valve box cleanouts, manholes, fire hydrants or other appurtenances for purposes of conveying potable water or waste water discharge.

Grantee or its assign, upon initial installation and upon each and every occasion that the Grantee enters upon the premises, for whatever reason, including but not limited to repairs, replacements, renewals, additions or removals, shall restore the premises of Grantors and any improvements disturbed by the Grantee to the same condition as the premises were prior to any such installation, work or other reason for entry, and such restoration shall include, but not be limited to, restoration of any topsoil or lawn.

Grantors retains all other rights to the premises, the subject of this easement, including but not limited to right to use the surface of the land for walkways, drive-ways, planting or all other purposes not inconsistent with

this easement, and all facilities or equipment placed upon the land by Grantee, pursuant to this easement, shall be at a depth consistent with Grantors' purposes.

By acceptance of this easement, the Grantee affirms that the premises shall be included in and considered as satisfying, in whole or part, the requirements for any set-backs or landscaping pursuant to the ordinances of Grantee.

This grant is further conditioned upon the substantial completion of the construction of the roadway as designed and submitted to the City of Wilsonville on or about August 1984, which is adjacent to this easement, within three years from the date hereof. If such roadway is not so substantially completed within such time, the grant of this easement shall be null and void and all rights conveyed to Grantee herein shall revert to Grantors.
