

RESOLUTION NO. 429

A RESOLUTION APPROVING THE BID; ACCEPTING THE LOWEST QUALIFIED BID SUBMITTAL; AND AWARDING THE CONTRACT TO TOWN AND COUNTRY FENCE CO., CLACKAMAS, OREGON, FOR CHAIN LINK FENCING FOR THE WIEDEMANN PUMP STATION AND CHARBONNEAU RESERVOIR.

WHEREAS, the City Council adopted Resolution No. 417 titled "A RESOLUTION AUTHORIZING STAFF TO REJECT ALL BIDS AND TO REBID THE CHAIN LINK FENCING FOR THE WIEDEMANN PUMP STATION AND CHARBONNEAU RESERVOIR" at its regularly scheduled meeting on August 6, 1984; and

WHEREAS, advertisements were printed in the Daily Journal of Commerce on September 4, 5 and 6, 1984 and the Oregonian on the same dates, as set forth in the requirements established in Oregon Revised Statutes 279.025 "REQUIREMENTS FOR ADVERTISEMENT"; and

WHEREAS, sealed bids were received prior to 10:00 o'clock a.m. Daylight Savings Time on Wednesday, September 12, 1984 at Wilsonville City Hall, 30000 SW Town Center Loop East, Wilsonville, Oregon, 97070. Bids were then opened individually and separately and read aloud after 10:00 o'clock a.m. Daylight Savings Time on September 12, 1984 and are listed in the attached Exhibit "A"; and

WHEREAS, the city staff has reviewed all bids received for completeness, additions and omissions, etc., and, therefore, acknowledges Town and Country Fence Co., Clackamas, Oregon as the lowest qualified bidder and recommends that Town and Country be awarded the contract for the chain link fencing for Wiedemann Pump Station and Charbonneau Reservoir project for a total construction cost of seven thousand, one hundred fifty-three dollars and twenty-eight cents (\$7,153.20); and

WHEREAS, funds for the construction of the chain link fencing for Wiedemann Pump Station and Charbonneau Reservoir project are to be allocated from Account No. 03-55-71315 of which funds are available for payment of construction costs according to the Finance Director of the City of Wilsonville.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Wilsonville that:

1. The City Council acknowledges that all bids were received, publicly opened and approved as being completed for consideration for award according to the provisions of Oregon Revised Statutes 279.025, "Requirements for Advertisements".
2. Accepting the contract of the lowest qualified bidder and awarding the contract for the low qualified bid to Town and County Fence Co., Clackamas, Oregon,

for a total bid price of seven thousand, one hundred fifty-three dollars and twenty-eight cents (\$7,153.28) for the chain link fencing for Wiedemann Pump Station and Charbonneau Reservoir project.

3. Authorize the expenditures of funds from Account No. 03-55-71315 for payment of costs attributed to the low bid from Town and Country Fence Co.
4. All payments for monthly construction billings shall be approved by the Public Works Director prior to payment of the billing. All Change Orders or Field Changes shall be approved by the City Council prior to issuance of payment.

ADOPTED by the Wilsonville City Council at a regular meeting thereof this 17th day of September, 1984 and filed with the City Recorder this same date.



RE: WELL FENCING BIDS

The bid opening for the Chain Link Fencing at Wiedemann Pump Station and Charbonneau Reservoir was held on September 12, 1984, at City Hall, Wilsonville, Oregon, with the following results.

Town and Country Fence	\$7,153.28
Zochert Fence Company	\$7,192.32
Pacific Fence & Wire	\$8,387.00
Don Pearson	\$10,985.85

City staff has reviewed all bids for completeness, additions and omissions and acknowledges Town and Country Fence Company as the low bidder and, therefore, recommends that Town and Country Fence be awarded the contract.

As you are aware, this project has been rebid. The first low bid was \$8,966.40 and the current low bid is \$7,153.28 which represents a net savings of \$1813.12. I feel this is a substantial savings and warranted the rebid of this project.
