ACTION REQUIRED: (1) Authorize the installation of:

a. One - 3" Rockwell water meter

b. One - 3" Clow water valve

c. One - 3" Subco

backflow preventor

d. One UV 575 LA water meter vault

for the Stafford Motor Inn by A & A Drilling at a lump sum price of \$3,500.00. Installation price includes all new materials provided in item 1 through 4, equipment and labor. City staff will excavate meter vault site; A & A Drilling shall complete the remainder.

CONCLUSIONARY FINDINGS

- A & A Drilling does all tapping of large mains in the City. 1.
- 2. The City's costs for new materials alone was estimated at \$3,892.10 without labor and equipment.
- 3. The pass through savings would be to the Stafford Motor Inn, since they are acquiring water connection from the City.
- 4. A & A Drilling normally does all the City tapping installation for meters above 2" in size, and would tap this 3" anyway.
- 5. Being that A & A Drilling's equipment will be at the site to tap the main, completing the meter installation is not only efficient but cost effective.
- 6. A & A Drilling has a business license with the City, and is bonded and insured, as required for all taps made in the City.
