A RESOLUTION APPROVING THE DETAILED PLANS AND SPECIFICATIONS, AND AUTHORIZING STAFF TO ADVERTISE TO RECEIVE SEALED BIDS FOR THE PARKWAY AVENUE REALIGNMENT, ELLIGSEN ROAD IMPROVEMENT PROJECT LID #9 - LANDSCAPING CONSTRUCTION.

WHEREAS, the City of Wilsonville authorized the formation of the project known as Parkway Avenue Realignment-Elligsen Road Improvement Project Local Improvement District No. 9, hereinafter referred to as LID #9 at its regularly scheduled City Council meeting held July 5, 1983 at 7:30 o'clock p.m. at the Willamette Valley Wesleyan Church; and

WHEREAS, LID #9 project construction costs included funding for installation of landscaping which is to be completed under a separate contract for this specialized type of installation as indicated in Resolution No. 424, A Resolution Spreading and Levying Preassessments on Property Benefited for the Cost of Construction of Street Sections, Drainage Installations, Water System Installations, Sanitary Sewer Installations, Sidewalk Installations, Signing and Traffic

Control Device Installations, Street Lighting Installations. Landscaping Installations, and Other Utilities Constructed for the Project Designated as "Parkway Avenue Realignment and Elligsen Road Road Improvement Project - Local Improvement No. 9" Hereinafter Referred to as L.I.D. #9; District and Directing the City Recorder to Give Notice of Final Preassessment and Enter a Statement Thereof in the Docket of City Liens as Required by Section 3.216 of the Wilsonville Code"; and

WHEREAS, plans and specifications have been reviewed by staff and are in compliance with the Wilsonville Code, Capital Improvements Plan, Public Works Standards and all applicable rules and regulations pertaining to construction within public rights-of-way of the City of Wilsonville or LID #9 Landscaping Construction; and

WHEREAS, staff is requesting approval to advertise for bids of LID #9 Landscape Construction so that construction work can begin in July of 1986.

NOW, ,THEREFORE, IT IS HEREBY RESOLVED BY THE CITY OF WILSONVILLE THAT:
