Savings Time, did approve Resolution No. 479 titled "A Resolution Adopting the Preliminary Engineer's Report Dated May 3, 1985, Declaring the Intention to Proceed Forward with the Construction, Establishing a Date, Place and time for a Public Hearing, Appointing the Three (3) Member Board of Viewers, Instructing the City Engineer, C. R. S.
