**BOONES FERRY PARK** 

The Parks and Recreation Department received four proposals for playground requipment scheduled for installation in Boones Ferry Park.

A wide range of playground equipment was proposed by the respondents, with two of the manufactures listing more than one option for equipment.

The City has a maximum of \$4,000.00 for the purchase of this equipment. The range of proposals is as follows:

Based on a review of the proposals staff recommends acceptance of the proposal from Wildwood Playgrounds in the amount of \$4,000.00. The basis for recommendation of Wildwood Playgrounds system is the following:

- 1. Provides a warranty equal to or better than any other manufacture...
- 2. Provides proposal within exsisting funding.
- 3. Provides eighteen different motion activities with a greater diversity and age range when compared to the minimum requirements and other manufactures proposals.

- 4. The benefit to the community and the park system from these added systems far outways the slight increase in cost above other proposals being considered.
- 5. The Wildwood Playground System is modular in nature and easily adapts to a most advantageous arrangement for the Boones Ferry Park setting.
