Bids were opened for the new Wilsonville Library on Thursday, November 5, 1987 at 3:00 p.m. After analyzing the bids, our architect has recommended in his report that the bid of Lonigan Construction be accepted. The base bid came in \$153,176 less than the architect's estimate. It should be noted that when the bonds were sold they were based on the architect's estimate. In addition, the city was approved for a Library Construction Grant which should be in the range of \$90 - \$100,000. In designing our bond sale, an extraordinary call feature was included which will allow the city to pay some bonds early depending on the final actual cost of construction and the amount received from the grant. This should result in significant savings for Wilsonville taxpayers.

One final item. It has come to my attention that there has been concern raised about the per square foot cost of the building. If a calculation is made for the contract items related only to the library building itself, the cost per square foot is in the range of \$45 - \$50. Other work including parking, civil, landscaping, etc. add significantly to the cost, but the building itself should come in at \$45 - \$50. Another factor which is of concern is the fact that since this is a public project of over \$10,000, Oregon's "Little Davis Bacon" prevailing wage rules apply. What this does is drive up the cost of the project due to mandated wage rates which must be paid to construction workers on the project. Oregon cities have approached the legislature to have this mandate repealed to no avail. One contractor informed me and another informed the architect that they did not bid on the project due to this law. It is clear to me that this law results in higher bids and less competition on public projects. The actual costs are extremely difficult if not impossible to quantify. I expect that cities will again attempt to have this law repealed at the next legislative session.

Dear Mr. Wall:

We have generally reviewed the Bids submitted by the Contractors for the Wilsonville Library Project and recommend executing an Agreement in the Stipulated Form with Lonigan Construction Company to complete the project.

A clarification should be made on the Contract Documents/Contract Agreement that Alternate Number 3 Bid (additional total cost required for site work and foundation work required during "Wet Weather" conditions and Geotechnical Engineer's as per Construction recommendations) shall be the maximum/not to exceed figure. The Contractor shall provide an itemized breakdown along with his Pay Request, verifying payment for "wet" conditions. Contractor shall credit Owner should cost not reach maximum after completion of site work and foundation work. Should the total cost required for site and foundation work required during "wet" conditions be exceeded, the Contractor shall bear all costs, and the Owner shall bear no costs.

Another clarification should be made on the Contract Documents/Contract Agreement regarding Plan Sheet AS2 where a guanular fill material shall be clarified to read "..with not more than 5% fines passing the No. 200 sieve.." (see attached letter from Civil Engineer, John Barbieri, November 6, 1987).

We have contacted three Portland Architectural firms that have worked with Lonigan Construction Company and their comments have been "very favorable" for this Project.

We therefore recommend execution of the Agreement with Lonigan Construction Company for the Base Bid (and approved Alternates) contingent upon receipt of approved Performance Bond and Labor & Materials Payment Bonds, Certificate of Insurance, Contractor Wage and Labor Certificate and Section 3 Compliance Data.

- 3. List of subcontractors proposed for this Project.
- 4. As per Federal Regulations, Section 3 Compliance Data: Subcontractors Certification and/or other evidence showing full compliance with all laws regarding Equal Employment Opportunity.
- 5. Contractor Wage and Labor Certificate
- 6. Performance Bond
- 7. Labor & Materials Payment Bond
- 8. Certificate and Endorsement of Insurance

Dear Mr. Wall:

Regarding Alternate Bids, as per our telephone conference this morning, we are recommending that the Owner exercise Alternate Number 3 and Alternate Number 4.

We are recommending the Base Bid (crawl space) Floor Framing/Foundation of Post and Beam System in lieu of the Slab/Foundation System for the following reasons:

- 1. Flexibility for future maintenance, remodel or addition regarding mechanical ductwork, plumbing and electrical work.
- 2. Library Staff expressed the need for a more resilient floor system for the user/worker.
- 3. Eliminates possible moisture problems often encountered in concrete slab floors.
- 4. Per committee discussions, the "crawl space" idea was always first choice and that the slab system was inserted as an alternate should the bidding figures go over the estimated budget.

Alternate Number 2, complete use of wood siding at the exterior of the building, may be eliminated since the brick and siding in the Base Bid is preferred.

Alternate Number 3, should be exercised if construction of the project is to begin soon, considering the time of year, and our Oregon "unpredictable" weather. (Refer to correspondence dated November 9, 1987 regarding this Alternate.)

We recommend Alternate Number 4 to help in sun control, glare and privacy.

We recommend not exercising Alternate Number 5, but this may be for committee discussion and decision. We feel that the layout shown on the Base Bid Plan (light fixtures perpendicular to the book stack layout) is "good design" and allows for flexibility in furniture (and book stacks) layout while allowing for required lighting. We have discussed this matter with Mr. Dick Waters, Library Consultant and he agrees with our design layout. He mentioned that the "parallel lighting to book stack" layout is used where furniture/book stacks remain in a fixed position in a "long term" situation. (NOTE: The bid amount for this Alternate by Lonigan Construction is questionable.)
