## **RESOLUTION NO. 648**

A RESOLUTION OF THE CITY OF WILSONVILLE, OREGON, CALLING A SPECIAL ELECTION TO SUBMIT TO THE VOTERS THE QUESTION OF CONTRACTING A WATER SYSTEM REVENUE BOND INDEBTEDNESS IN AN AMOUNT NOT TO EXCEED \$2,320,000 TO FINANCE WATER SYSTEM IMPROVEMENTS INCLUDING A NEW WATER STORAGE RESERVOIR, ADDITIONAL WELLS AND WATER MAINLINES.

WHEREAS, a report on the City's water system has been reviewed and approved by the City Council; and

WHEREAS, the report indicates a critical need for water system improvements; and

WHEREAS, the City's financial consultant has recommended that the improvements be financed by water system revenue bonds; and

WHEREAS, the Wilsonville City Council desires to seek as much citizen input as possible into this issue by holding an election to allow Wilsonville citizens the opportunity to vote on the issuance of water revenue bonds.

NOW, THEREFORE, THE CITY OF WILSONVILLE, OREGON RESOLVES AS FOLLOWS:

A. An election is hereby called for the purpose of submitting to the qualified voters of the City the question of contracting a water system revenue bond indebtedness in an amount not to exceed \$2,320,000 for a term not to exceed 20 years.

B. The election hereby called shall be held in the City on the 22nd day of March, 1988.

C. The ballot title as contained in Exhibit "A" attached "Notice of Measure Election" is hereby adopted.

D. The City Recorder shall cause to be delivered to the Elections Officer of Clackamas County the attached Notice of Bond Election, not later than 34 days prior to the election. The Elections Officer shall conduct the election as required by law.

E. That the City Recorder shall give notice of the election by posting notice in three public places at least two weeks prior to the election.
