

**RESOLUTION NO. 686**

**A RESOLUTION ENDORSING THE REPORT BY WILSONVILLE INNOVATIVE TRANSPORTATION ASSOCIATION (WITA) REGARDING WITHDRAWAL OF THE CITY OF WILSONVILLE FROM TRI-MET.**

WHEREAS, WITA is an organization formed by the Wilsonville business community for the purpose of studying public transit needs for the City of Wilsonville; and

WHEREAS, WITA has conducted a public survey and hearings regarding transit needs in Wilsonville; and

WHEREAS, WITA has prepared an in-depth study regarding public transit and the feasibility of withdrawal of the City of Wilsonville from Tri-Met; and

WHEREAS, the results of this study find that Wilsonville citizens could receive improved public transportation services through a local transit system at a lower cost to Wilsonville businesses based on the current Tri-Met payroll tax; and

WHEREAS, no property or other city taxes other than a payroll tax on business will be used to finance city operation of a transit system thereby resulting in no direct taxes to Wilsonville citizens.

**NOW, THEREFORE, THE CITY OF WILSONVILLE CITY COUNCIL RESOLVES AS FOLLOWS:**


Section 1. The Wilsonville City Council endorses the study and findings of the WITA Transportation Development Plan.

Section 2. The Wilsonville City Council supports a cooperative withdrawal of the City of Wilsonville from Tri-Met based on improved public transportation through a local transit system in the City of Wilsonville provided that any such withdrawal does not prohibit the

City of Wilsonville from re-entering Tri-Met if it would result in an improved public transportation in the City of Wilsonville at a later date.


Section 3. The City Recorder is directed to forward a copy of this Resolution to the Tri-Met Board of Directors upon passage by the City Council.
