In the process of advertising for bids on a new replacement sludge truck chassis, an alternate bid was submitted by Roberts Motor Co.

This alternate bid was for a Kenworth Model T450 which did not meet the requested specifications concerning the engine horsepower. The City specified a 350 hp engine and the truck submitted on the alternate bid by Roberts Motor Co. is equipped with a 285 hp engine. However, it is the opinion of the City's mechanic Dave McKay, that the 285 hp would be sufficient for the City's use.

Because this truck has been used quite extensively as a demonstrator, and has over 800 miles on it, it is my opinion and the opinion of the City attorney that this vehicle is a used vehicle and may be purchased under Oregon Administrative Rule #125-310-075 which allows purchase of used personal property over \$10,000 with three competitive quotes, or a written record of the attempt to obtain quotes. Dave McKay has contacted dealers in the area concerning the purchase of used equipment and has been unable to find any other vehicles that would meet the City's requirements.

Considering that the City is currently paying approximately \$1,000 per month for the rental of a sludge truck and the unavailability of used trucks meeting our specifications and requirements, I recommend the following:

RECOMMENDATION:

Authorize the purchase of the used Kenworth T450 from Roberts Motor Co., Portland, at a cost of \$56,262.00. Delivery to be provided within ten days.
