RESOLUTION NO. 729

A RESOLUTION ADOPTING INTERIM CITY OF WILSONVILLE PUBLIC WORKS STANDARDS.

WHEREAS, on July 2, 1979, the City of Wilsonville established procedures and specifications for developers or engineers to submit construction plans to the City; and

WHEREAS, the City has set forth uniform material and workmanship standards under which all public works facilities shall be constructed within the City; and

WHEREAS, the intent for establishing standard specifications for public works construction is to streamline the administration and construction of public works facilities within the City; and

WHEREAS, the standard specifications for public works construction in the City of Wilsonville shall cover all public street, drainage, water, sewer and appurtenant facilities within the corporate limits of Wilsonville, whether constructed by the City, or constructed privately and turned over to the City for maintenance and operation; and

WHEREAS, the standard specifications relate <u>only</u> to public works construction in the City, and should not be confused with building codes, zoning ordinances and other regulations for which procedures and standards have been established. Planning, zoning and related matters should first be satisfied prior to referral of a project to the Engineering Department for review of proposed facilities; and

WHEREAS, the standard specifications may be amended or updated from time to time upon recommendation by the City Engineer and appropriate action to do so by the City Council.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

The City of Wilsonville Public Works Standards, as updated and presented by the City Engineer in 1988, are hereby adopted as the interim standards for public works construction in the City until such time as the standards may be presented to the City Council in their final format.

ADOPTED by the Wilsonville City Council at a regular meeting thereof this 3rd day of July, 1989, and filed with the Wilsonville City Recorder this same date.

INTERIM ENGINEERING STANDARDS

On June 17, 1988, City Engineer Dick Drinkwater, P.E., P.L.S., presented a rough draft revision of the Public Works Standards for review and comment. The draft has since been used on a daily basis for administering plan reviews and new construction. The adopted 1979 Standards are outdated especially in terms of specifications for construction materials and practices. New advances have been made in manufactured products used for utilities, and D.E.Q. and Health Department regulations have been revised for sewer and water construction practices.

The draft revision also contains changes in street section widths and design standards. These changes will have a direct impact on the City's Comprehensive Plan and the Wilsonville Code. The proper procedure for changes to street section design standards is to first make the necessary Comprehensive Plan change through the Planning Commission before final adoption by the City Council. The goal is to complete the formal procedure in the fall, 1989.

However, the recently adopted LID formation ordinance clearly refers to "adopted public works standards" for the administration of LID projects. It may be in the best interest of the City to adopt, by resolution, interim public works standards which could be used to administrate potential LID, payback and daily engineering projects.
