WHEREAS, the owners of Lots 2, 3, 4, 5, 6, 7 and 8, Block F, Wilsonville, have filed a petition requesting that the City Council vacate a public alley and a portion of 3rd Street; and

WHEREAS, the property owners have deposited a vacation fee with the City that is sufficient to cover the cost of publication and posting of public notice and other expenses; and

WHEREAS, the Wilsonville City Council finds that this is an appropriate time to address the property owners request.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- (1) The City Recorder shall publish and post the public notice required by ORS 271.110 Notice of Public Hearing; and
- (2) A public hearing shall be scheduled for September 21, 1992 at the City Council's regular meeting to be held at 7:00 pm at the Community Development Hearings Room.




