

**RESOLUTION NO. 1004**

**A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE MAY 18, 1993 SPECIAL ELECTION.**

WHEREAS, at the Special Election held May 18, 1993, the electorate of the City of Wilsonville cast ballots for Ballot Measure 3-2, a three year serial levy of \$1.00 per \$1,000 for street maintenance, Library services and Parks & Recreation programs in the City of Wilsonville; and

WHEREAS, the electorate of the City of Wilsonville also cast ballots for Ballot Measure 3-3, a three year serial levy of \$1.10 per \$1,000 for street maintenance, improved Library and Parks & Recreation services in the City of Wilsonville; and

WHEREAS, the election of the registered voters of Clackamas County and Washington County was conducted by mail; and

WHEREAS, the County Clerks of Clackamas and Washington Counties, who by statute, are in charge of conducting all elections, have filed an abstract of the tally of votes cast at the election, which tally was received from Clackamas County on May 25, 1993 and from Washington County on May 27, 1993.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. That the City Council of the City of Wilsonville does hereby adopt the votes as follows:
