

RESOLUTION NO. 1058

A RESOLUTION AMENDING RESOLUTION NO. 1026 AND SETTING FORTH A CORRECTED RATE TABLE TO INCREASE FEES FOR USERS OF THE CITY OF WILSONVILLE WATER SERVICES.

WHEREAS, water user fees are reviewed annually by the City Council; and

WHEREAS, the City Council determined that water user fees be increased by ten percent, and adopted Resolution No. 1026; and

WHEREAS, within the body of Resolution No. 1026, Table I, Domestic Water User Fees, the per cubic foot calculation had been listed incorrectly at .01 when it should have been .0097; however, this calculation overage was discovered and no one has been improperly billed.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1) Water user fee rates are amended and listed in the following table, effective November 1, 1993.


