## **RESOLUTION NO. 1176**

## A RESOLUTION OF THE CITY OF WILSONVILLE REQUESTING THE TRANSFER OF JURISDICTION OF SW RIDDER ROAD (COUNTY ROAD NO. 558 and No. 561); A PORTION OF SAID ROADS WHICH LIE IN WASHINGTON COUNTY LYING BETWEEN THE BALLDOCK FREEWAY (I-5) AND SW GARDEN ACRES ROAD.

WHEREAS, the City of Wilsonville has received a petition from 100% of the affected property owners requesting that the city initiate the formation of a Local Improvement District (LID #11-94-ST); and

WHEREAS, the improvements to be constructed in association with LID #11-94-ST specifically address the reconstruction of a portion of SW Ridder Road currently under the jurisdiction and control of Washington County; and

WHEREAS, if said transfer takes place, the completion of the public improvements along SW Ridder Road can be completed in accordance with the adopted Transportation Master Plan (July 1991) of the city of Wilsonville; and

WHEREAS, the completion of the public improvements in association with LID #11-94-ST, in accordance with city standards, would be in the best interests of the City; and

WHEREAS, Washington County has offered the city of Wilsonville the sum of \$71,000 to initiate and complete the transfer of jurisdiction of the outlined portion of SW Ridder Road as contained herein; and

WHEREAS, if said transfer of jurisdiction takes place in a timely manner, there would no delay in the completion of the public improvements associated with LID #11-94-ST; and

WHEREAS, ORS 373.270(6) provides a means and mechanism for Washington County to transfer jurisdiction of county roads within a specific city to the city; and

WHEREAS, the City of Wilsonville has determined, if necessary, expedient and in the best interest of the City to acquire jurisdiction over portions of SW Ridder Road (County Road No. 558 and No. 561) in part thereof to the same extent that it has over other public streets and alleys of the City.

NOW THEREFORE THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. The City Council hereby requests that the county commissioners of Washington County, Oregon transfer jurisdiction of those county roads described and epicted as Exhibits "A" and "B" attached hereto to the city of Wilsonville.

2. The City of Wilsonville hereby requests that the county commissioners of Washington County, Oregon compensate the City of Wilsonville in the sum of \$71,000 for said transfer. Said sum representing the estimated costs of remedial repairs on SW Ridder Road.

ADOPTED by the City Council of the City of Wilsonville at a regular meeting thereof on the 15th day of May, 1995, and filed with the Wilsonville City Recorder this date.
