RESOLUTION NO. 1417

A RESOLUTION OF THE CITY OF WILSONVILLE AMENDING RESOLUTION NO. 982, PERTAINING TO THE PACIFIC STREET PROJECT, REVISING EXHIBIT "A" LEGAL DESCRIPTION AND MAP (PROJECT NO. 530-49130-5000-443).

WHEREAS, Resolution No. 982, adopted by the City Council March 1, 1993, is entitled "A Resolution Authorizing the City of Wilsonville to Negotiate and Acquire Land for the Construction of a Portion of Town Center Loop West Street Extension Improvements and the Pacific Street Extension to S.W. Parkway Avenue and for the Construction of the Town Center Loop East Street Extension Improvements and the Memorial Park Sewer Line Extension Improvement"; and

WHEREAS, Exhibit "A" of Resolution No. 982 included identification by legal descriptions and maps the rights of way through Truax and Larsen properties required for the public purpose of providing the Pacific Street Extension improvements; and

WHEREAS, these legal descriptions were titled "Legal Description Pacific Street Through Larsen Property" and "Legal Description Pacific Street Right of Way Through Truax Property"; and

WHEREAS, after further analysis it was deemed necessary to revise Exhibit "A" legal descriptions and maps to reflect changes in the engineering design of the improvements; and

WHEREAS, staff recommends amending Exhibit "A" of Resolution No. 982 to correctly reflect the property interest required for the Pacific Street project.

NOW, THEREFORE, THE CITY OF WILSONVILLE CITY COUNCIL RESOLVES AS FOLLOWS:

1. The rights of way legal descriptions and maps identified as "Legal Description Main Street Right of Way Dedication James B. Larsen" and "Legal Description Main Street Right of Way Dedication Truax Harris Energy Company", attached hereto, shall be identified as replacement portions of Exhibit "A" of Resolution No. 982.


